



RISK ASSESSMENT FOR A WORKING TRIAL

Effective Planning is concerned with prevention through identifying, eliminating and controlling hazards and risks.

A risk assessment is a careful examination of what could cause harm to people on the trial ground. The risk assessment enables organisers to determine whether there are sufficient precautions in place, or if more needs to be done to prevent harm being realised.

The five step approach:

1. Look for the hazards
2. Decide who may be harmed and how
3. Evaluate the risks
4. Record the finds
5. Review the assessment

INSERT PATROL

Likelihood/Probability

- 1 Highly Unlikely = has never occurred
- 2 Unlikely = has only occurred once or twice in 10 years
- 3 Possible = has occurred
- 4 Likely = common occurrence

Severity

- 1 Minor Harm = Cuts, abrasions and minor skin or eye irritations, etc.
- 2 Slightly Harmful = any injury that requires First Aid
- 3 Harmful = (Broken Limb or Non-permanent incapacity)
- 4 Major Harm = Permanent disablement

Remember you have a "Duty of Care" to all who attend your trial.

Lone Workers with issues

Tracklayers Escorts

Base and Trials Manager to hold mobile phone numbers and vice versa. Checks that lone workers are ok during the day and have returned at the expected time.

Clear instructions for competitors needing to be sent on to their track/control field.
